Update: As a result of the votes from 36 members via survey monkey voted on or before 27<sup>th</sup> January 2023, Deaf Australia will be postponing the vote for the Constitution and change of company until we have completed the community consultations. - 6. Adoption of 36<sup>th</sup> Annual Financial Report
  Debra Presented the 36<sup>th</sup> Annual Financial Report which was audited by Ryk Eksteen of
  Collins and Co. and based on feedback from the AGM the following was discussed:

- Auspices Our constitution does outline that we can provide auspice services to
  organisations (under Part1-Statement of Objectives 1.1.7: to provide advice, assistance
  and support either directly or indirectly to organisations of and for Deaf people upon
  their request and after consultations with the state association involved whenever
  appropriate). Currently we have the following:
  - a) Deaf Blind Victoria Joined DA mid-2020
  - b) Deaf Hub Bendigo Joined DA in February 2022
  - c) Deaf Mental Health Fund Joined DA in late 2022
- 2. **Profit/Loss** for Deaf Australia for the year ended 30 June 2021 is at -\$8,196.
- 3. Income Stream for 2021/22:

- 4. Large 'Sundry' expense: This was approved by the board due to contribution for ustome fees for products worth over \$1K to sell at Auslan Shop, Gift vouchers for Volunteers who had supported us, Project cost for both Deaf Hub Bendigo and Deaf Blind Victoria.
- 5. **Travel and accommodation:** In March 2022, DA host a Board and Staff retreat in Sydney. Staff also met with Deaf Community on various project to gather information and feedback such as Cairns for Deaf Census Project, Newcastle for Health meeting.
